
CONTRACT OF LEASE OF VENUE

MAPA, Ph.D., National Statistician and Civil Registrar General, duly represented in RSSO XIII (Caraga Region), Freeman Building, J.C. Aquino Avenue, Butuan City by GUILLERMO M. LIPIO, JR., Chief Statistical Specialist/ Officer-in-Charge, of legal age, single and a resident of Washington, Surigao City, Surigao del Norte, Philippines, hereinafter referred to as "FIRST PARTY";



- 2. That the SECOND PARTY will provide LUNCH, AM/PM SNACKS, and FUNCTION ROOMS/HALLS based on the rate given.
- 3. That the FIRST PARTY shall pay the total amount of TWO HUNDRED THOUSAND EIGHT HUNDRED FIFTY **EIGHTEEN** (PhP218,850.00)
- 4. That the SECOND PARTY will not be held liable for any losses of jewelries, money, and other valuable things of the FIRST PARTY other than those formally endorsed to the front desk or office.
- 5. That no alteration will be allowed by the SECOND PARTY to the FIRST PARTY and thereafter than the increased number of participants, that any





additional in excess of the minimum set, extra meals maybe arranged at the rate agreed upon to be shouldered by the FIRST PARTY.

- 6. That payments supported by receipts or properly logged in the contract will be considered valid.
- 7. The parties hereby expressly submit to the jurisdiction of the courts of Agusan del Norte on any legal action arising from this contract.
- 8. This contract shall be for a period of SIX (6) DAYS, 08-13 JULY 2024. However, it is understood that the termination shall be effective only upon notification in writing by any of the parties before or on the date of the termination date.
