KNOW ALL MEN BY THESE PRESENTS:

This **CONTRACT** entered this 27th day of March 2024 in the City of Butuan, Philippines, by and between:

The PHILIPPINE STATISTICS AUTHORITY (PSA), created under Republic Act 10625 with principal office at PSA Complex, East Avenue, Diliman, Quezon City, Philippines with UNDERSECRETARY CLAIRE DENNIS S. MAPA, Ph.D., National Statistician and Civil Registrar General, duly represented in RSSO XIII (Caraga Region), Freeman Building, J.C. Aquino Avenue, Butuan City by ROSALINDA C. APURA, D.M., Regional Director, of legal age, married and a resident of Barangay 5, San Francisco, Agusan del Sur, Philippines, hereinafter referred to as "LESSEE";

- and -

BUTUAN GRAND PALACE HOTEL, a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines with office address at San Jose St., Butuan City, represented in this act by its Operation Manager, **J.R. ARAIZ CASGAPA** now hereafter referred to as the "**LESSOR**".

WITNESSETH:

WHEREAS, the LESSEE will conduct the 2023 Census of Philippine Business and Industry (CPBI) with a rider 2023 Input-Output Survey of Philippine Business and Industry (IOSPBI) Second Level Training from 01 to 05 April 2024;

WHEREAS, the conduct of the 2023 Census of Philippine Business and Industry (CPBI) with a rider 2023 Input-Output Survey of Philippine Business and Industry (IOSPBI) Second Level Training will be from 01 to 05 April 2024 within Butuan City and will require a venue including lunch and snacks (am &pm) for 21 participants from 01 April to 05 April 2024, and 18 participants for dinner and accommodation with complimentary breakfast from 01 April to 04 April 2024, and dinner, accommodation with complimentary breakfast for 11 participants on 31 March 2024 (Arrival), and dinner for 2 participants on 05 April 2024 with accommodation and complimentary breakfast.

WHEREAS, the PSA finds the lease of venue including meals and accommodation under Section 53.10 of the Implementing Rules and Regulation of Republic Act 9184 most advantageous to the government;

WHEREAS, the LESSOR for the lease of venue including meals and accommodation is the lowest bidder and passed the qualification requirements set using the rating form based on the RA 9184, otherwise known as the Government Procurement Reform Act;

WHEREAS, the Regional Bids and Awards Committee (RBAC) passed RBAC Resolution No. 2024-085 dated 27 March 2024 recommending for the approval by the Head of the Procuring Entity to declare the bid/quotation of the LESSOR as the Single Calculated and Responsive Quotation (SCRQ) and to award the contract in the amount of two hundred thirteen thousand and seven hundred fifty pesos only (PhP213,750.00);

WHEREAS, the LESSEE issued the Notice of Award to the LESSOR dated 27 March 2024;

NOW, THEREFORE, and in consideration of the foregoing premises and of terms and conditions hereinafter provided, it is hereby agreed that:

I. OBLIGATIONS

A. LESSOR

- The LESSOR shall provide and deliver the listed items in strict compliance with the inclusions and specifications stipulated in the table in Annex "A":
- 2. The **LESSOR** shall provide a venue, accommodation, and catering services as specified in the table in **Annex "B"**:
- The LESSOR shall submit a billing statement within three (3) days after providing all the items.

B. PSA - RSSO XIII

 The LESSEE shall pay the contract price to the LESSOR in the total amount of two hundred thirteen thousand and seven hundred fifty pesos only (PhP213,750.00);

II. DURATION OF CONTRACT

This contract shall be for the period April 01-05, 2024.

III. OTHER TERMS AND CONDITIONS

This Contract of Lease of Venue may be amended or supplemented through the execution of a contract variation. Such variation in the contract shall be effective only on the date and for its period stated therein and provided that both parties
