This **CONTRACT** entered this 18th day of January 2024 in the City of Butuan, Philippines, by and between:

The PHILIPPINE STATISTICS AUTHORITY (PSA), created under Republic Act 10625 with principal office at PSA Complex, East Avenue, Diliman, Quezon City, Philippines with UNDERSECRETARY CLAIRE DENNIS S. MAPA, Ph.D., National Statistician and Civil Registrar General, duly represented in RSSO XIII (Caraga Region), Freeman Building, J.C. Aquino Avenue, Butuan City by ROSALINDA C. APURA, D.M., Regional Director, of legal age, married and a resident of Barangay 5, San Francisco, Agusan del Sur, Philippines, hereinafter referred to as "LESSEE";

ROBINSONS LAND CORPORATION (Go Hotels), a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines with office address at J C Aquino Ave, Butuan City, 8600 Agusan Del Norte, represented in this act by its Hotel Associate, KATHERINE F. WITNESSETH:

WHEREAS, the LESSEE will conduct the April 2024 Labor Force Survey (LFS) Second Level Training from 26 to 27 March 2024;

WHEREAS, the conduct of the April 2024 Labor Force Survey (LFS) Second Level Training will be from 26 to 27 March 2024 within Butuan City and will require a venue including meals and snacks for 15 participants from 26 March to 27 March 2024, and as well as accommodation with complimentary breakfast and dinner for 6 participants on 25 March 2024 (Arrival), accommodation with complimentary breakfast and dinner for 15 participants and am and pm snacks, and lunch, for 15 participants on March 26, 2024, and am and pm snacks and lunch for 15 participants on March 27, 2024;

WHEREAS, the PSA finds the lease of venue including meals and accommodation under Section 53.10 of the Implementing Rules and Regulation of Republic Act 9184 most advantageous to the government;

WHEREAS, the LESSOR for the lease of venue including meals and accommodation is the lowest bidder and passed the qualification requirements set

using the rating form based on the RA 9184, otherwise known as the Government Procurement Reform Act;

WHEREAS, the Regional Bids and Awards Committee (RBAC) passed RBAC Resolution No. 4042 dated 12 - 20 - 2025 recommending for the approval by the Head of the Procuring Entity to declare the bid/quotation of the LESSOR as the Single Calculated and Responsive Quotation (SCRQ) and to award the contract in the amount of sixty thousand twenty-two pesos and fifty centavos only (PhP60,022.50);

WHEREAS, the **LESSEE** issued the Notice of Award to the **LESSOR** dated _______;

NOW, THEREFORE, and in consideration of the foregoing premises and of terms and conditions hereinafter provided, it is hereby agreed that:

I. OBLIGATIONS
