# **CONTRACT AGREEMENT**

THIS AGREEMENT made the  $24^{\text{th}}$  day of  $300^{\circ}$  2024 between Philippine Statistics Authority – RSSO XIII, located at J.C. Aquino Avenue, Butuan City, of the Philippines (hereinafter called "the Entity") of the one part and Kimson Commercial, located at R. Calo St., Butuan City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the Procurement of Information and Communications Technology (ICT) Supplies and Materials, Office Supplies, Printing Equipment, and Other Supplies and Materials for Survey Operations and Data Processing of PSA RSSO XIII and its PSOs for Lot 3 (Inks and Toners (Genuine) and Lot 4 (Office Supplies, and Other Supplies and Materials) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Four Hundred Twenty-Two Thousand Four Hundred Twenty-Three Pesos Only (P422,423.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
