

CONTRACT AGREEMENT



THIS AGREEMENT made the 24 day of June 2024 between *Philippine Statistics Authority – RSSO XIII, located at J.C. Aquino Avenue, Butuan City* of the Philippines (hereinafter called “the Entity”) of the one part and *Strawhats Printing and Design, located at Door 5 Piquero Complex Hope Ave., KM 7 Bangkal Talomo, Davao City* (hereinafter called “the Supplier”) of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the *Procurement of Information and Communications Technology (ICT) Supplies and Materials, Office Supplies, Printing Equipment, and Other Supplies and Materials for Survey Operations and Data Processing of PSA RSSO XIII and its PSOs for Lot 5 (Customized Polo Shirt, Bag, and Umbrella) and Lot 6 (Magic Mug)* and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Four Hundred Eighteen Thousand Two Hundred Five Pesos and 21/100 Only (P418,205.21)** (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder’s conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

In consideration for the sum of Four Hundred Eighteen Thousand Two Hundred Five Pesos and 21/100 Only (P418,205.21) or such other sums as may be ascertained, *Strawhats Printing and Design* agrees to *provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the contract* in accordance with his/her/its Bid.
4. The *Philippine Statistics Authority – RSSO XIII* agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




