**CONTRACT OF LEASE OF VENUE  
FOR THE POPCEN-CBMS CITY/MUNICIPAL LEVEL TRAINING OF LGU MAINIT, LGU  
ALEGRIA AND LGU TUBOD**

**KNOW ALL MEN BY THESE PRESENTS:**

This **CONTRACT** entered on the **29 June 2024**, in the City of Butuan, Agusan del Norte, Philippines, by and between:

The **PHILIPPINE STATISTICS AUTHORITY (PSA)**, created under Republic Act 10625 with principal office at PSA Complex, East Avenue, Diliman, Quezon City, Philippines with **UNDERSECRETARY CLAIRE DENNIS S. MAPA, Ph.D.**, National Statistician and Civil Registrar General, duly represented in RSSO XIII (Caraga Region), Freeman Building, J.C. Aquino Avenue, Butuan City by **GUILLERMO M. LIPIO, JR.**, OIC-Regional Director, of legal age, single and a resident of Barangay Washington, Surigao City, Surigao del Norte, Philippines, hereinafter referred to as **"PSA"**.

**KASILI LAKESIDE RESORT AND HOTEL**, a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines with office address in Barangay Quezon, Municipality of Mainit, Surigao del Norte, represented in this act by its Proprietor, hereafter referred to as the **"SUPPLIER"**;

**WITNESSETH:**

**WHEREAS**, the PSA will conduct the POPCEN-CBMS City/Municipal Level Training of LGU Mainit, LGU Alegria and LGU Tubod;

**WHEREAS**, the abovementioned activity will be conducted on July 1 to 6, 2024 and July 8 to 13, 2024 in the Municipality of Mainit, Surigao del Norte which will require a venue and accommodation including meals and snacks for seven participants on the said dates;

**WHEREAS**, the PSA finds the lease of venue and accommodation including meals and snacks under Section 53.10 of the Implementing Rules and Regulation of Republic Act 9184, otherwise known as the Government Procurement Reform Act, most advantageous to the government;

**WHEREAS**, the SUPPLIER for the lease of venue and accommodation including meals and snacks is the single bidder and passed the qualification requirements set using the rating form based on the RA 9184;

**WHEREAS**, the Regional Bids and Awards Committee (RBAC) passed RBAC Resolution No. 2024-\_\_ dated June 20, 2024, recommending for the approval by the Regional Director to declare the bid/quotation of the SUPPLIER as the Sole Bidder and to award the contract in the amount of Two Hundred Seventy Five Thousand Forty Pesos and 00/100 (Php275,040.00) only;

**WHEREAS**, the PSA issued the Notice to Proceed to the SUPPLIER dated June 29, 2024;

NOW, THEREFORE, and in consideration of the foregoing premises and of terms and conditions hereinafter provided, it is hereby agreed that:

**B. PSA Surigao del Norte**

1. The PSA shall provide the list of menus for meals and snacks at least two days before the delivery date;
2. The PSA shall provide the list of names of participants for the training venue; and
3. The PSA shall pay the contract price to the SUPPLIER in the amount of Two Hundred Seventy Five Thousand Forty Pesos and 00/100 (Php275,040.00) only.

**II. DURATION OF THE CONTRACT**

This contract shall be for the period July 1 to 13, 2024.

**III. OTHER TERMS AND CONDITIONS**


This contract may be amended or supplemented through the execution of contract of variation. Such variation in contract shall be effective only on the date and for the period stated therein, provided that both parties agree to the terms and conditions stated. Any contract variation is deemed integral and amendatory part of this contract.






