This CONTRACT entered into this 21st day of June 2024 in the City of Butuan, Philippines, by and between:

The PHILIPPINE STATISTICS AUTHORITY (PSA), created under Republic Act 10625 with principal office at PSA Complex, East Avenue, Diliman, Quezon City, Philippines with UNDERSECRETARY CLAIRE DENNIS S. MAPA, Ph.D., National Statistician and Civil Registrar General, duly represented in RSSO XIII (Caraga Region), Freeman Building, J.C. Aquino Avenue, Butuan City by GUILLERMO M. LIPIO, JR., (Chief Statistical Specialist)/Officer-in-Charge, of legal age, single and a resident of Barangay Washington, Surigao City, Philippines, hereinafter referred to as "PSA";

WHEREAS, the SUPPLIER for the lease of venue with catering services and accommodation is the single bidder and passed the qualification requirements set using the rating form based on the RA 9184, otherwise known as the Government Procurement Reform Act;

WHEREAS, the Regional Bids and Awards Committee (RBAC) passed RBAC Resolution No. 1/14 recommending for the approval by the Regional Director to declare the bid/quotation of the SUPPLIER as the Single Calculated and Responsive Quotation (SCRQ) and to award the contract in the amount of (a) Lot 12: P336,800.00 (b) Lot 13: P332,200.00, and (c) Lot 16: P314,600.00 or a total contract price of NINE HUNDRED EIGHTY-THREE THOUSAND SIX HUNDRED PESOS only (Php983,600.00);
