This **CONTRACT** entered into this 2nd day of September 2024 in the City of Butuan, Philippines, by and between:

The **PHILIPPINE STATISTICS AUTHORITY (PSA)**, created under Republic Act 10625 with principal office at PSA Complex, East Avenue, Diliman, Quezon City, Philippines with **UNDERSECRETARY CLAIRE DENNIS S. MAPA, Ph.D.**, National Statistician and Civil Registrar General, duly represented in RSSO XIII (Caraga Region), Freeman Building, J.C. Aquino Avenue, Butuan City by **GUILLERMO M. LIPIO**, **JR.**, Chief Statistical Specialist, Officer-in-Charge Regional Director, of legal age, single, and a resident of Surigao City, Surigao del Norte, Philippines, hereinafter referred to as "**LESSEE**";

BUTUAN GRAND PALACE HOTEL, a Corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines with office address at Capitol Drive, Montalban St., Butuan City, represented in this act by its Operation Manager, J.R. ARAIZ CASGAPA now hereafter referred to as the "LESSOR".

WITNESSETH:

WHEREAS, the LESSEE will conduct the 2024 Annual Poverty Indicators Survey (APIS) Data Processing Second Level Training;

WHEREAS, the conduct of the 2024 Annual Poverty Indicators Survey (APIS) Data Processing, Second Level Training will be on 02 to 05 September 2024 within Butuan City and will require a dinner and accommodation for 12 pax on 02 September 2024, a venue, AM and PM snacks and lunch for 28 participants on 03 to 05 September, and dinner and accommodation for 16 pax on 03 to 04 September, and dinner and accommodation for 1 pax on 05 September 2024;

WHEREAS, the PSA finds the lease of venue including catering services and accommodation under Section 53.10 of the Implementing Rules and Regulation of Republic Act 9184 most advantageous to the government;

WHEREAS, the LESSOR for the lease of venue including catering services and accommodation is the lowest bidder and passed the qualification requirements set using the rating form based on the RA 9184, otherwise known as the Government Procurement Reform Act;





WHEREAS, the Regional Bids and Awards Committee (RBAC) passed RBAC Resolution No. 2024-____ dated 02 September 2024 recommending for the approval by the Head of the Procuring Entity to declare the bid/quotation of the LESSOR as the Single Calculated and Responsive Quotation (SCRQ) and to award the contract in the amount of one hundred thirty-three thousand fifty pesos only (Php 133,050.00).

WHEREAS, the LESSEE issued the Notice of Award to the LESSOR dated 02 September 2024;

NOW, THEREFORE, and in consideration of the foregoing premises and of terms and conditions hereinafter provided, it is hereby agreed that:

I. OBLIGATIONS

A. LESSOR

- The LESSOR shall provide and deliver the listed items in strict compliance with the inclusions and specifications stipulated in the table in Annex "A":

- 3. The **LESSOR** shall submit a billing statement within three (3) days after providing all the items.

B. PSA – RSSO XIII

1. The **LESSEE** shall pay the contract price to the **LESSOR** in the amount of one hundred thirty-three thousand fifty pesos only (Php 133,050.00).

II. DURATION OF CONTRACT

This contract shall be for 02 to 05 September 2024.

III.OTHER TERMS AND CONDITIONS

This Contract of Lease of Venue may be amended or supplemented through the execution of a contract variation. Such variation in contract shall be effective only on the date and for its period stated therein, and provided that both parties agree to the terms and conditions stated.
