**WHEREAS**, upon careful review and evaluation of the TWG, **Gold Bar N' Grill** was identified as the single eligible bidder;

**WHEREAS**, the TWG conducted an evaluation using the approved Rating Factors for the Lease of Venue and visited **Gold Bar N' Grill** on 03 June 2025 at 2:00 PM;

**WHEREAS**, based on the evaluation (Annex 1), **Gold Bar N' Grill** obtained a rating of **92.95 percent** and passed the requirements set forth by PSA for the Lease of Venue with Catering Services and Accommodation for the conduct of July 2025 Labor Force Survey (LFS) and Family Income and Expenditure Survey (FIES) Visit 1 Provincial Level Training on June 30 to July 05 & 07, 2025; (Please see Annex 1 – Evaluation Report and Annex 2 – Accomplished Rating Form);
